Following the conclusion of the evaluation phase, for proposals submitted under the “1st Call of the Action ‘Science & Society’ –‘200 years from the Greek Revolution’”(Ref.No. 1564/27.04.2018, as in force) with the publishing and dissemination of the decision of the provisional results by the Evaluation Committee [Ref. No.(H.F.R.I.) 17296/07.10.2019] and the (decision Ref.No. 17381/08.10.2019) of the 65th meeting of the Scientific Council (S.C.) of H.F.R.I. on the approval of the publishing of the relevant temporary ranking on the website of the Foundation, here follows:

Temporary Ranking of Proposals (2nd Evaluation Phase).

The proposals are ranked in descending order, with the total final score of each proposal and the score of sub-Criterion B (Evaluation of the proposed project).

In case of a tie between the proposals in the Temporary Ranking Table, the one with the highest score in this criterion is proposed in accordance with the provisions of the Call (Section 9). It is pointed out that according to the Call, **up to ten (10) proposals** will be selected to be funded with an amount of up to € 100,000 per proposal.
