Following the conclusion of the 1st evaluation phase for proposals submitted under the “**2nd Call for H.F.R.I. Research Projects to Support Faculty Members and Researchers**” (Ref. No. 20741/08.01.2020) in the Scientific Areas **C. Life Sciences (Medicine and Health Sciences) (SA.3)** and **H. Environment and Energy (SA.8)** as well as the Decision of the H.F.R.I.’s Scientific Council (SC) at its 100th meeting (Ref. No. 35571/05.04.2021) regarding the publishing of the evaluation results, here follow:
