Establishment of a Scientific Committee for the Hellenic Foundation for Research and Innovation

## THE ALTERNATE MINISTER OF EDUCATION, RESEARCH AND RELIGIOUS AFFAIRS

Having regard to:

1. The provisions of:
a) Presidential Decree 63/2005 (Gov. Gazette, Series I, 98) 'Codification of Legislation for the Government and Government Bodies' and, in particular, Article 90 'Control of expenditures resulting from regulatory administrative acts';
b) Presidential Decree 114/2014 (Gov. Gazette, Series I, 181) 'Organisation of the Ministry of Education and Religious Affairs';
c) Presidential Decree 70/2015 (Gov. Gazette, Series I, 114) 'Re-establishment of the Ministries of Culture \& Sport, Infrastructure, Transport and Networks, Rural Development and Food; Re-establishment of the Ministry of Shipping and the Aegean and renaming thereof into the Ministry of Shipping and Island Policy. Renaming of the Ministry of Culture, Education and Religious Affairs into the Ministry of Education, Research and Religious Affairs, of the Ministry of Economy, Infrastructure, Shipping and Tourism into the Ministry of Economy, Development and Tourism and of the Ministry of Productive Reconstruction, Environment and Energy into the Ministry of Environment and Energy; Transfer of the General Secretariat for Industry to the Ministry of Economy, Development and Tourism';
d) Presidential Decree 73/2015 (Gov. Gazette, Series I, 116) 'Appointment of a Deputy Prime Minister, Ministers, Alternate Ministers and Deputy Ministers';
e) Prime Ministerial Decision No Y136/20-03-2015 (Gov. Gazette, Series II, 389) 'Establishment of posts of Alternate Ministers'; f) Prime Ministerial Decision No Y8/25.9.2015 (Gov. Gazette, Series II, 2109) 'Assignment of powers to Alternate Minister of Education, Research and Religious Affairs Konstantinos Fotakis';
g) Article 13(1) of Law 4429/2016 (Gov. Gazette, Series I, No 199), we decide:
A. To establish a five-member (5-member) scientific committee, to specify the qualifications of the members of the Scientific Council and of the Director of the Hellenic Foundation for Research and Innovation (H.F.R.I.) as follows:
2. Georgios Papatheodorou, son of Nikolaos (Identity Card No: AZ 208659), Professor Emeritus at the University of Patras, as Chairman;
3. Georgios Simos, son of Merkourios (Identity Card No: Al 847806), Professor of Biochemistry at the Faculty of Medicine of the University of Thessaly;
4. Emmanouil Floratos, son of Gerasimos (Identity Card No: X653659), Professor Emeritus at the University of Athens, as a member;
5. Nektarios Tavernarakis, son of Nikolaos (Identity Card No: AK 470784), Professor at the School of Medicine of the University of Crete, as a member;
6. Theodoros Papazoglou, son of Gavriil (Identity Card No: AM 606901), Head of Unit at the Executive Agency of the European Research Council, as a member;
B. The task of the Scientific Committee is to specify the qualifications of the members of the Scientific Council and of the Director of the H.F.R.I. in compliance with the provisions of Articles 8 and 9 of Law 4429/2016, respectively. The relevant decision of the Committee shall be published in the Government Gazette. On the basis of these criteria, the Scientific Committee shall publish calls for applications for the Scientific Council and the post of Director of the H.F.R.I. Following the publication of the calls, the Scientific Committee shall automatically be dissolved.
C. Scientific Committee members of the are not entitled to any fee or other compensation for their participation in the Committee. Angeliki Nakou, daughter of Ioannis, Identity Card No AM 120510, an employee of the Hellenic Pasteur Institute, shall serve as secretary of the committee, her substitute being Ifigeneia Efthymiou, daughter of Christos, Identity Card No AB 044506, an employee of the Minister of Education, Research and Religious Affairs. This decision shall be published in the Government Gazette.
