Having regard to:

decides:

1. To appoint Christina Foka, daughter of Polyvios, an Economist, Identity Card No AZ 638368, as the Deputy Director competent for Administration affairs at the H.F.R.I., under full-time, exclusive employment, for a four-year term which may only be renewed once.
2. To appoint Deputy Director Christina Foka as the Substitute of the Director under Article 9(4) of Law 4429/2016.
