# THE DEPUTY MINISTER OF DEVELOPMENT AND INVESTMENTS

### Having regard to:

- 68183/1.07.2020 (Issue for Specially Positioned Employees and Administrative Bodies of Public or Broader Public Sector Entities No. 490)
- 12. Decision No. 28706/08.10.2020 adopted by the General Assembly of the H.F.R.I. at its 12th Meeting on the "a) Preparation and publication of a call for expression of interest to fill nine member positions of the H.F.R.I.'s Scientific Council and b) Designation of a nine-member Appointment Committee for the evaluation of the candidates and the preparation of a candidates list for each sector, according to the evaluation order";
- 13. Call for expression of interest no. 28817/12.10.2020 regarding the selection of nine (9) regular members for the H.F.R.I.'s Scientific Council (IUN: 6ΠΤ846Μ77Γ-ΓΗΖ);
- 14. The H.F.R.I.'s document no. 34677-17.03.2021, through which decision no. 34676/17.03.2021 adopted by the H.F.R.I.'s General Assembly at its 16th meeting on the "Selection of nine regular members for the H.F.R.I.'s Scientific Council" was communicated to the agency;
- 15. The fact that the fees received by Scientific Council members for their participation to the meetings are charged to H.F.R.I.'s budget, in line with the ministerial decision no. 136480-17/08/2018 on "Fees determination for the Chair and the members of the H.F.R.I.'s Scientific Council" (Issue for Specially Positioned Employees and Administrative Bodies of Public or Broader Public Sector Entities No. 481), decides the following:
- A. The establishment of the Scientific Council of the Hellenic Foundation for Research and Innovation, following the end of the four-year term of the Council, which had been established by the Ministerial Decision No. 288/03-04-2017 on the «Establishment of the Scientific Council of the Hellenic Foundation for Research and Innovation» (Issue for Specially Positioned Employees and Administrative Bodies of Public or Broader Public Sector Entities No. 173), based on article 8, par. 4 of Law 4429/2016 on the "Hellenic Foundation for Research and Innovation and other provisions" (199/A), as amended and in force.
- B. The composition of the H.F.R.I.'s Scientific Council shall be renewed per sector as follows:
- 1. Agricultural Sciences: George John Nychas, son of Emmanouil, Professor at the Department of Food Science and Technology of the Agricultural University of Athens, holder of the ID Card No. AK 221376.
- 2. Physical Sciences: Constantine Galiotis, son of Georgios, Professor at the Department of Chemical Engineering of the University of Patras, holder of the ID Card No. Φ 440280.
- 3. Mathematics and Information Sciences: Evangelos Markatos, son of Pavlos, Professor at the Department of Computer Science of the University of Crete, holder of the ID Card No. AB 959457.
- 4. Social Sciences: Xenia Chryssochoou, daughter of Dimitrios, Professor at the Psychology Department of the Panteion University, holder of the ID Card No. AI 100633.
- 5. Humanities: Antonios Rengakos, son of Vasileios, Professor at the School of Philology of the Aristotle University of Thessaloniki, full member of the Academy of Athens, holder of the ID Card No. AK 852043.
- 6. Environment and Energy: Stylianos Neophytides, son of Georgios, Research Director at the Institute of Chemical Engineering Sciences of the Foundation for Research and Technology Hellas, holder of the ID Card No. 522625 of the Republic of Cyprus.

- 7. Medicine and Health Sciences: Charalampos Savvakis, son of Eleftherios, Professor Emeritus at the School of Medicine of the University of Crete, Collaborating Researcher at the Biomedical Sciences Research Centre "Alexander Fleming", holder of the ID Card No. Al 941487.
- 8. Engineering Sciences and Technology: Emmanouil Kakaras, son of Konstantinos, Professor at the School of Mechanical Engineering of the National Technical University of Athens, holder of the ID Card No. AI 576830.
- 9. Innovative Entrepreneurship: Konstantinos Charitidis, son of Adam, Professor at the School of Chemical Engineering of the National Technical University of Athens, holder of the ID Card No. AE 318636.
- C. The members of the Scientific Council shall hold office for a term of four years, starting from 12th April 2021.
