Research Project Synopsis

The ninth-century Greek grammarian Theognostus straddles the divide between the ancient and Byzantine worlds. His work (entitled 'Canones' or 'On orthography') on correct Greek spelling is vital for our knowledge and understanding of ancient grammar as it preserves much ancient scholarly material from ancient grammarians, whose work does not survive in its original form. From yet another angle, this work is important because of its influence on the etymological lexica composed by later Byzantine scholars, while at the same time it provides us with a rare insight into ninth-century linguistic thought. But to date Theognostus' work has received far less attention than it deserves, owing to the lack of any proper edition of the text: the only full publication of Theognostus' Canones ('Rules') ever produced, which dates to 1835, is a transcript of a single manuscript. Since this publication is not a critical edition, it contains many passages that simply fail to make sense.

In 1964 Alpers edited the beginning of the *Canones* (rules 1-84 out of a total of 1,006) taking into account four manuscripts. Today we know of two more manuscripts, but these have not yet been taken into account in the context of a critical edition. Neither of the two previous editions, then, took into consideration all the extant manuscripts, and although Alpers' edition significantly improved the text, it covers less than 10% of this lengthy work.

The main outcome of my research project will be a monograph on Theognostus' *Canones*, including the first complete critical edition of this text, based on a thorough examination of all the surviving manuscripts and accompanied by a full introduction, critical apparatus, and apparatus of parallel passages. This will make Theognostus' work accessible both to Classical scholars and to Byzantinists and thus allow it to fulfil its potential usefulness to both fields.



Project originality

My monograph on Theognostus' *Canones* will include the first complete critical edition of this text, based on a thorough examination of all the surviving manuscripts and accompanied by a full introduction, critical apparatus, and apparatus of parallel passages. This will make Theognostus' work accessible both to Classical scholars and to Byzantinists and thus allow it to fulfil its potential usefulness to both fields.
