Second (2nd) amendment of the decision under No. 69615-3/5/2018 titled: "Annual planning of actions and resource allocation of the Hellenic Foundation for Research and Innovation (H.F.R.I.) for 2018".

THE DEPUTY MINISTER

OF DEVELOPMENT AND INVESTMENTS

Having regard to:

1. Par. 1 of article 5 of Law 4429/2016 "Hellenic Foundation for Research and Innovation and other provisions" (A' 199).

2. Article 90 of the "Government and Governmental Bodies Code" (presidential decree 63/2005 - A' 98) maintained by par. 22 of article 119 of Law 4622/2019 (A' 133).

3. The Presidential Decree 81/2019 on the "Establishment, merger, renaming and abolition of Ministries and definition of their responsibilities - Transfer of services and responsibilities among Ministries" (A' 119).

4. The Presidential Decree 83/2019 on the "Appointment of a Deputy Prime Minister, Ministers, Alternate Ministers and Deputy Ministers" (A' 121).

5. The Presidential Decree 84/2019 on the "Establishment and abolition of General Secretaries and Special Secretariats/Single Administrative sectors within the Ministries" (A' 123).

6. Article 3 of the Presidential Decree 3/2021 on the renaming of the General Secretariat for Research and Technology of the Ministry of Development and Investments to General Secretariat for Research and Innovation (A' 3).

7. The Prime Minister's decision No. Y2/2019 on the "Establishment of positions for the Alternate Minister and Deputy Ministers" (B' 2901).

8. The Prime Minister's Decision No. Y48/1.8.2019 on the "Assignment of responsibilities to the Deputy Minister of Development and Investments, Christos Dimas" (B' 3100).

9. The ministerial decision No. 288/03-04-2017 on the "Establishment of the Scientific Council of the Hellenic Foundation for Research and Innovation" (Issue for Specially Positioned Employees and Administrative Bodies of Public or Broader Public Sector Entities 173).

10. Decision No. 69615-3/5/2018 issued by the Alternate Minister of Education, Research and Religious Affairs on the "Annual planning of actions and resource allocation of the Hellenic Foundation for Research and Innovation (H.F.R.I.) for 2018" (B' 1907).

11. Decision No. 133182-20/12/2019 on the "Annual planning of actions and resource allocation of the Hellenic Foundation for Research and Innovation (H.F.R.I.) for 2020 (B' 4885).

12. Decision No. 38463-28/07/2021 (correction) adopted by H.F.R.I.'s Scientific Council at its 110th Meeting on the "Submission of proposal to the competent Deputy Minister of Development and Investments for the 2nd amendment of the ministerial decision No. 69615/2018 (B' 1907) on the annual planning of actions and resource allocation of H.F.R.I. for 2018" (IUN: Ψ8ΛΠ46Μ77Γ-ΞΓΨ).

13. The fact that the provisions of this decision shall not incur expenditure to the State budget, we decide:

A. We amend the decision No. 69615/2018 (B' 1907) issued by the Alternate Minister of Education, Research and Religious Affairs on the "Annual planning of actions and resource allocation of the Hellenic Foundation for Research and Innovation (H.F.R.I.) for 2018", as amended by decision No. 133182/2019 (B' 4885) on the "Annual planning of actions and resource allocation of the Hellenic Foundation for Research and Innovation (H.F.R.I.) for 2020, by increasing the budget of item 1 of par. A of its enacting part by EUR 3,000,000.

B. Par. A of the enacting part of this decision is worded as follows:

"A. Annual planning of actions of the Hellenic Foundation for Research and Innovation (H.F.R.I.) for 2018, as follows:

1. Main research - Research projects of Faculty Members and Researchers: EUR 27,500,000.

2. Scholarships for PhD Candidates: EUR 8,000,000

3. Research projects of Postdoctoral Researchers: EUR 16,580,000

4. Research equipment: EUR 7,560,000

5. Science and Society: EUR 3,000,000".

C. The increase in the budget of item 1 of par. A of the enacting part of the decision No. 69615/2018 (B' 1907) comes from the returns on H.F.R.I.'s cash.

D. As far as the remainder is concerned, the decision No. 69615/2018 (B' 1907), as amended by the decision No. 133182/2019 (B' 4885), remains unchanged.

This decision shall be published in the Official Government Gazette.
