The evaluation of the Proposals submitted to Scientific Fields **5.1** "Study of inclusive societies", **5.2** "Communication, Mass Media and Social Influence", **5.4** "Development of innovative applications and sustainable business models", and **5.5** "Development of innovative governance policies and models" of the Thematic Area TA5 "Social Sciences, Humanities & Arts, Management & Economics of Innovation" under Sub-action **2** of the Call "Basic Research Financing (Horizontal support of all Sciences), National Recovery and Resilience Plan (Greece **2.0**)" (Ref. No 52921/25.08.2022) has been completed after the examination of the Objections against the Evaluation Decisions [Cover letters with Ref.No (HFRI) 65894/02.05.2023 and 65896/02.05.2023] and the issuance and transmission of the re-evaluation Decisions of the competent Evaluation Committees [Ref.No.. 68294/12.06.2023 (Scientific Fields: **5.1** & **5.2**) and 68293/12.06.2023 (Scientific Fields: **5.4** & **5.5**)].

Following the completion of the aforementioned procedure and the issuance of the Decision under Ref.No. 68710/17.06.2023 of the 157<sup>th</sup> meeting of HFRI's Scientific Council, the posting of the final ranking tables on the Foundations's website was approved.). Here follow for each Scientific Field:

- 1. The final ranking table of the Proposals selected for funding with an evaluation grade A listed by descending score,
- 2. The final ranking table of the Proposals' reserve list with an evaluation grade A listed by descending score (where applicable), and
- 3. The final ranking table of the Proposals with an evaluation grade B, listed by descending score.

In case two or more Proposals obtain the same overall score in the ranking, the Proposal that has obtained the highest score in Criterion "2. Research Proposal" takes precedence. Proposals with an overall score below 3.5 (threshold) in each of the two Criteria separately, as well as in total, are excluded from funding.

The allocation of the Proposals to the Thematic Areas is based on the PI's statement by the Proposal submission.
