ANNOUNCEMENT OF PRELIMINARY EVALUATION RESULTS AND PRELIMINARY RANKING

The Action is implemented under the National Recovery and Resilience Plan "Greece 2.0" with funding from the European Union - NextGenerationEU.







The evaluation of the Proposals submitted in the **Thematic Area 5, Scientific Field 5.3 "Digital Humanities & Social Sciences" under Sub-action 2 of the Call "Basic Research Financing (Horizontal support of all Sciences), National Recovery and Resilience Plan (Greece 2.0)"** (Ref. No 52921/25.08.2022) has been completed. The HFRI Scientific Council approved (Decision with Ref. No 68123/06.06.2023 of the 156th Meeting) the announcement of the preliminary ranking tables following the Decision of the respective Evaluation Committee (Ref. No. 68025/01.06.2023). Here follow for the above mentioned Scientific Field:

- 1. The preliminary ranking tables of the selected for funding proposals evaluated with A listed by descending score,
- 2. The preliminary ranking tables of the reserve list of the proposals evaluated with A listed by descending score,
- 3. The preliminary ranking tables of the proposals evaluated with B listed by descending score.

In case two or more Proposals receive the same total score, the Proposal with a higher score in Criterion "2. Research Proposal" is listed higher. Proposals with a total score below 3.5 (threshold) in each of the two Criteria separately, as well as in total, are excluded from funding.

The allocation of the Proposals to the above Scientific Field is based on the PI's statement by the Proposal submission.
