The evaluation of the Proposals submitted to the Scientific Area **SA.9 “Management and Economics of Innovation”** of **Sub-action 1 under the Call “Funding Basic Research (Horizontal support of all Sciences)”**, **National Recovery and Resilience Plan (Greece 2.0)”** (Ref. No. 52921/25.08.2022) has been completed. The H.F.R.I. Scientific Council approved (Decisions with Ref. No. 63302/16.03.2023 of the 146th Meeting) the announcement of the preliminary ranking tables following the Decisions of the respective Evaluation Committees Ref. No. 63033/10.03.2023, here follow for the above mentioned Scientific Area:

1. The preliminary ranking tables of the selected for funding proposals evaluated with A listed by descending score,
2. The preliminary ranking tables of the reserve list of the proposals evaluated with A listed by descending score (where applicable),
3. The preliminary ranking tables of the proposals evaluated with B listed by descending score and,
4. The tables of the non-eligible proposals (where applicable).

In case two or more Proposals receive the same total score in the ranking, the Proposal with a higher score in Criterion “2. Research Proposal” is listed higher. Proposals with a total score below 3.5 (threshold) in each of the two Criteria separately, as well as in total, are excluded from funding.

The allocation of the Proposals to the Scientific Areas is based on the PI’s statement by the Proposal submission.
